

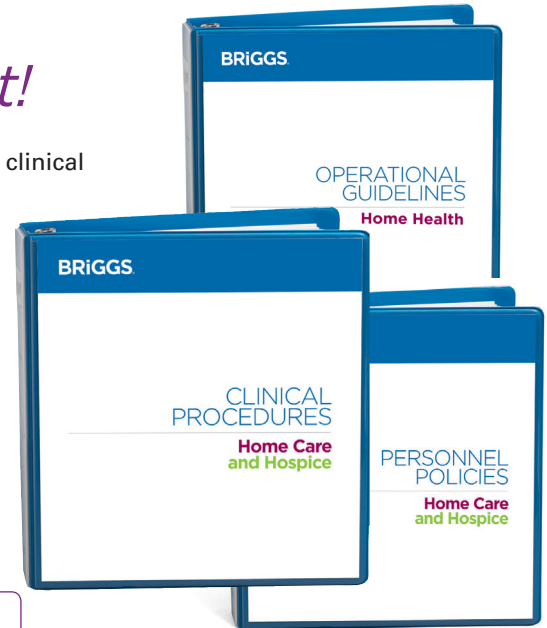

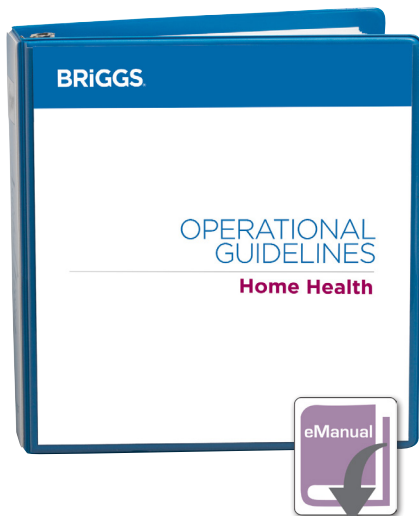

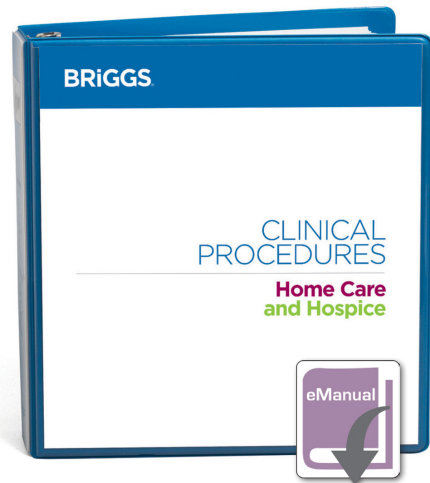
There are two crosswalks in the manual. One is for the Medicare regulations – cross referenced to the Condition of Participation. Not all policies are required by Medicare but are suggested by this author. These are referenced in the crosswalk with an R or S. The second crosswalk is for Accreditation (JCAHO, CHAP, and ACHC) Policies are cross walked to these requirements.

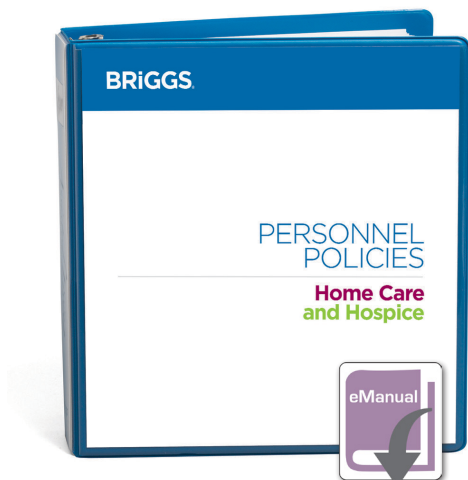
This manual was completely reviewed and updated in 2017. A section was added on personal cares to provide agencies with a foundation for assessing competencies. All of the procedures are arranged according to body systems. Each procedure is set up to identify who is trained to complete these procedures but also with a format that accommodates tailoring to the delegation of nursing tasks to unlicensed personnel as allowed by state and federal guidelines.
